Category Review of Anadromous Fish Habitat and Hatchery Projects

Dear Project Sponsors:

The Northwest Power and Conservation Council (Council) announces the start of the review process for **Anadromous Fish Habitat and Hatchery** projects funded under the Council's Columbia River Basin Fish and Wildlife Program (Program). The 135 projects in this review are provided in the list at the end of this letter.

This packet contains the information your team will need to complete the project proposal form for submission to the Council by **May 3, 2021**. Staff contact information is provided should you have questions after reading through this packet, or as you complete your proposal. All information contained in this packet can also be found on the Council's <u>Anadromous Review page</u>. The Council appreciates your participation in this review, and we look forward to working with you during this process.

Project Review Set

This review is limited to projects that are currently being funded under the Program. This is not a solicitation for new project proposals. However, sponsors of ongoing projects may wish to describe new work elements, phases, or objectives for their projects based on adaptive management or new priorities, within budget constraints.

Review Objectives and Outcomes

Most of these projects have been the subject of numerous reviews in the past. For that reason, important functions of this review will be to evaluate:

- project results and how each project has adapted proposed future work based on those results;
- how well the project sponsors have responded to the scientific and management issues identified in previous Council reviews and recommendations; and
- the collective progress of particular groups of projects that have a similar focus.

Independent Scientific Review Panel

The Northwest Power Act directs the Council to review projects proposed for funding by Bonneville to implement the Council's Fish and Wildlife Program. The Council engages in this review with the assistance of the Independent Scientific Review Panel (ISRP). The ISRP reviews proposals for consistency with the Program and makes recommendations to the Council as to whether these projects:

- are based on sound science principles;
- benefit fish and wildlife;
- have clearly defined objectives and outcomes; and
- have provisions for monitoring and evaluation of results.

For individual projects, the ISRP review will focus primarily on project performance by assessing the following project components:

- the degree to which project objectives are being achieved;
- accomplishments and results;
- the degree to which project objectives, actions, and methods reflect new information gained from those results; and
- clear delineation of progress towards completion.

Review materials

The materials to be used in the review by the ISRP and Council are listed below. The first two **bolded** items are the responsibility of the project sponsor to prepare and submit with this review.

- 1. **Project proposal** including 3-5 year budget using template provided.
- 2. **Other materials** that you feel are important such as maps, photos, scientific papers produced from the project work, etc. that are referenced in the proposal and are not already linked or included.
- 3. Project annual reports (project sponsors should ensure annual reports are up to date in Pisces, CBfish)
- 2014 Columbia River Basin Fish and Wildlife Program, 2020 Addendum, and the Program's <u>subbasin plans</u>
- 5. The most recent Council and ISRP review of your project, including relevant programmatic comments
 - Geographic Review of habitat restoration projects: Council <u>2013 decision</u> document and ISRP Final Report (2013-11)
 - RM&E and Artificial Production Review: Council <u>2011 decision document</u> and ISRP Final Report (<u>2010-44</u>)
 - More recent follow-up or Three Step reviews

6. Projects that provide context for the habitat or hatchery projects included in this review (see below).

This review will use a WORD template that project sponsors will complete and submit by email to the Council, rather than an online proposal form in cbfish.org. Project sponsors can access the <u>project proposal template here</u>, or by opening the template file attached to the February 2nd email to sponsors. Once you access the template, follow the instructions to begin the proposal.

Proposal Form Workshops

The Council will host two webinars in February to walk through the proposal form template, instructions and submission process. The webinars will also include guidance from the Council and the ISRP on how to develop quantitative biological objectives and your project evaluation and adjustment plan. Similar information will be presented at both webinars, so people can attend either one or both. The first webinar is scheduled for February 11, 1-4pm. The second webinar will be on February 25, 1-4pm.

Project Presentations

During the preliminary review period, project presentations will be organized to share information about projects, add context to the proposals, and provide an opportunity for

dialogue between the ISRP and project sponsors. Presentations should focus on results, accomplishments, adaptive management implications, and proposed work. Sponsors are encouraged to participate in project presentations as part of this review process. We will contact project sponsors to schedule time for presentations, which will likely occur in June and July. We anticipate that presentations will occur via webinar.

ISRP Reports

The ISRP's Preliminary Review Report of proposals will be complete on **September 23**, **2021**. It will provide written recommendations and comments on each proposal. For projects that meet the ISRP's scientific review criteria, those comments will be final and carryover to the ISRP's final report. If the proposal does not contain enough information or if issues need to be clarified, the ISRP may request a response from the project sponsor that will be due **November 22**, **2021**. The ISRP will review these responses and complete a Final Report by **February 10**, **2022**. This report will include final comments on all proposals and on cross-cutting programmatic issues.

Public Comment

The Council will make the ISRP's findings available to the public and will accept public comments on the ISRP's Preliminary Review Report and the Final Report. The public comment period will open on **September 24**, **2021** and close on **February 21**, **2022**.

Council Recommendations

To develop its final recommendations of projects to be funded through Bonneville, the Council will consider the recommendations from the ISRP's Final Report and any public comments received. In making its recommendations, the Council will explain its reasons for not accepting the ISRP's recommendations, if that is the case, and how it considered "the impact of ocean conditions on fish and wildlife populations" and determined whether the projects "employ cost-effective measures to achieve program objectives." The Council will also explain any other administrative or policy considerations that informed its recommendations.

Recommendations will come in the form of specific project implementation recommendations and programmatic recommendations. In most cases, project implementation recommendations will inform implementation from FY2023 until the next review cycle, unless otherwise noted. Programmatic recommendations are issues that may apply to all projects or a subset of projects, depending on the nature of the issue (science, administrative, or policy). Council recommendations are anticipated in April 2022.
